

# INFORMATION ON THE USE OF COOKIES

- **1. General information**

Please be informed that this website (hereinafter referred to as: the website) uses so-called 'cookies' in order to improve the quality of its services, to facilitate using the website (to enable the user to communicate and interact more easily with our website) and to manage security and privacy risks properly.

A cookie is a small piece of data (an arbitrary alphanumeric information packet) sent by the server of the website you are browsing to your device. The cookie is stored in the browser of your computer, telephone, or tablet, and can be read later by the sending server. The cookie cannot be read by another website only by the one which placed it. Cookies inform us about the habits how the visitors use the website. The Controller intends to use the cookies for administrative purposes; such as measuring the website traffic and making browsing easier by remembering the previously opened pages within the website. A cookie does not contain any personal information which would allow anyone to access you by email, over the telephone or by way of traditional mail. Cookies alone are not able to identify the user but are only suitable for recognizing the visitor's computer. If you do not wish to accept the use of cookies on our website, then you may also configure the web browser you are using to inform you of placing the cookies and even to prevent placing cookies.

- **2. Consent to using cookies**

We place cookies on your device (your computer, telephone or tablet) used to visit our website. When you start browsing our website you will be prompted to this in the window popping up when our home page is loaded. If you continue to browse our website after the pop-up window about the cookies appears, then you give your consent to our placing cookies on your computer, telephone or tablet in the manner and for the purposes described in this present policy.

**If you do not wish us to place the our website related cookies on your computer, telephone or tablet, do not use our website.** Even if you initially give your consent to using our cookies, **you may decide to disable and delete cookies at any time** in your web browser settings.

However, please note that without the use of cookies, you will not be able to access several features which make the experience of browsing easier or it may also happen that some of our services will not work properly.

- **3. Managing your cookie settings**

You can change your cookie settings through your browser. You can disable the use of cookies by activating the setting which allows you to reject the placement of all or certain cookies in your browser. These settings are usually accessible in your browser's 'settings' or 'preferences' menu. For more information, you may use the following links:

- **4. Types of cookies**

Cookies can be the so-called temporary or session cookies – these are only valid during the workflow – or persistent cookies – these are saved on your device – and we distinguish between first-party (internal) and third-party (external) cookies. In the following, you may read about what these terms mean so that you may better understand the cookies we use and why we use them.

- **5. Cookies valid during browsing**

Cookies which are valid during the browsing session allow us to recognize you when you visit our website and so the browser may remember any page changes or selections from page to page. These cookies allow you to navigate through many pages of a website quickly and easily without having to identify yourself or repeat processes on each page you visit (for example, while filling in a form). When you finish browsing the page or close the browser this type of cookies are automatically deleted from your device.

- **6. Persistent cookies**

Persistent cookies are cookies which remain 'persistent' on your computer for a certain period of time (their validity period is defined in days, weeks, months or years) after the browsing process expires, and this way they allow websites to recall the preferences or actions of users later on, during a visit to the given website (e.g., the user name or password which is valid on the given website can also be stored). The saved cookies will be stored on your device until the expiration date but you can delete them before the expiry of the preset deadlines.

- **7. Cookies from the operator of the website (first party cookies)**

These are cookies sent by the server of the website browsed. In this case, these are the cookies sent by the server that hosts the website operated by the Controller, the features and operation of which are detailed above. These remember the IP-address of your device and the pages you visited while using the website. This enables you not to have to repeat processes regularly – when you open a new page or return after leaving the website – by opening the same pages when you use the website.

These cookies are the so-called session cookies, so these are only valid during browsing. This means that if someone starts browsing the website, then the cookie gets activated and then remains valid up to 15 minutes after the last activity of the user.

- **8. Third party cookies**

Third-party cookies are not sent by the Controller or the server hosting the website. These cookies are also saved on your computer, telephone or tablet while you visit the website, as described below.

- **9. Google cookies**

The Google Analytics© files are needed to monitor the page and serve for obtaining information about the method of using the website (such as the number of visitors to the website, the pages viewed, the settlement from where the visitor is browsing, the other website from where the user is 'landing' on the website, the user's Internet browser, operating system, Internet service provider and the resolution of the monitor the user is just using, the duration of browsing the page or the time when the user left the website). We use this information to make statistics and further develop the website. Google Analytics files store information in an anonymous form. These files are set by Google Analytics.

Google Inc. (1600 Amphitheatre Parkway, Mountain View, CA 94043, USA) as the owner and operator of Google Analytics assets also accesses these anonymous data. Google Inc. also uses the above information to deliver targeted advertisements to the browser user. In doing so, Google Inc., by linking the anonymous data and the IP address of the browsing device, determines the range of interests which can be explored based on the browsing habits of that device, and then delivers targeted advertisements to that device. The Google Analytics© Cookies are the so-called persistent cookies, their storage lasts up to two years, but in practice this is between 2 hours and six months – depending on the type of cookies.

- **10. Log file entries**

The technical background which operates the website of the Controller uses log file entries. Log file entries can store the IP address, the type of the browser the visitor uses, the Internet service provider, the date/time stamp, the addresses of the linking and exit pages, and number of clicks during the visit. This is done so that we can retrieve the circumstances of an error in the case of a malfunction and make browsing more secure in the future. It makes it easier for us to manage and administer the website. The data are stored anonymously. If you do not consent to data processing with a device like this, please do not use our website.
